Call the Meeting to Order

Board Chair Annis Leslie called the regular board meeting to order at 6:00 pm.

Director Boisa motioned and Director Hagerty seconded to approve the agenda. Motion carried.

Reports

The Student report was presented by senior, Morgan Kirkpatrick. Morgan discussed winter sports. The wrestling team just had their last meet and the girls basketball team is 6th in the league. The boys basketball team is young but they are hanging tough. The speech team is having a good year and the winter formal had a good turn out. The recent blood drive had the best turn out in years.

Superintendent Phelps began his report by recognizing the board for their service. Mr. Phelps read the proclamation from Governor Brown, declaring January School Board Appreciation Month.
